Dear Wyoming Attorney

As inflation and gas prices rise this year the poor are hit the hardest. Less money means more loan defaults, evictions, and civil judgments. Financial stressors cause family problems like domestic violence, divorce, custody and child support disputes. The number of people requesting our services never seems to reduce.

Legal Aid of Wyoming is one of a handful of organizations attempting to fill the justice gap and provide for indigent individuals who are unable to afford civil legal representation. We rely on donations and grants to pay for our services and as always **Legal Aid services are free to those who qualify.**



But all of our efforts are not enough, we consistently turn down 6 of every 10 applicants for lack of resources. Rule 6.1 of the Wyoming Rules of Professional Conduct recommends that each attorney give fifty (50) hours of pro bono legal services work per year or donate \$500 to an organization such as Legal Aid of Wyoming.
