Passport to Cash

RULES

Each time you send us a customer who purchases or leases a vehicle, new or used, car or truck, you will receive a check. Either call us before hand to let us know they're coming, or else have the customer mention your name at the time of sale. You will have to bring this card into Tyrrell for validation once the sale is complete. All prizes must be claimed within 90 days of issue date. This must be documented and approved the day the vehicle is sold. If you do not have a current payment, your second referral in 30 days will be \$300. To have your payment made requires 2 purchasing referrals in 30 days. Fleet purchases are ineligible. Limit on referral prize per sale.
